

RULES & REGULATIONS

Event is open to vehicles & Motorcycles from 1900 thru 1974
with the exception of any year Corvette

ALL PRE-REGISTRATIONS MUST SUBMIT COLOR PHOTO AND COPY OF D.M.V. REGISTRATION WITH APPLICATION - NO EXCEPTIONS!
(PHOTO AND COPY OF D.M.V. REGISTRATION WILL NOT BE RETURNED)

LIMITED TO THE FIRST 1,700 APPROVED ENTRIES

Entry Forms will be placed in the order received according to postmark date to begin reserved parking placement.

PRE-REGISTRATION - on or Before August 1, 2011: \$70.00 Pre-Registration includes: 4-days reserved parking space with assigned number, two (2) participant credentials, one (1) official "Participant" t-shirt, a license plate. Eligible to participate at no charge in the neon light contest, the open header contest, the Cruisin' Hall of Fame Ceremony on Saturday, and an opportunity to receive a sponsor's choice award.

To Pre-Register, registration must be postmarked on or before August 1, 2011
Registrations WILL NOT be accepted from Aug. 2, 2011 through Sept. 14, 2011

Your canceled check will confirm that we have received and processed your application. Your registration is considered to be accepted unless you hear otherwise from our office. Information packets will be mailed mid-August to Pre-Registered Participants.

NEW ONSITE REGISTRATION - Beginning September 15-18, 2011: \$80.00 (Based on availability.) New On-Site Registration - DOES NOT include an official participant t-shirt. On-Site Registration Includes: 4-days reserved parking space with assigned number, two (2) participant credentials, and a license plate. Eligible to participate at no charge in the neon light contest, the open header contest, the Cruisin' Hall of Fame Ceremony on Saturday, and an opportunity to receive a sponsor's choice award.

GROUP OR CLUB PARKING: If you would like to park together or as a club, you must submit your vehicle entry forms in one (1) packet. Number and place the forms in the order of who you would like to park next to.

NEW ON-SITE REGISTRATION:

If Space is Available...

Sept. 15 through Sunday, Sept. 18, 2011

- ♦ Copy of current D.M.V. Registration.
- ♦ Your vehicle or a color photo of vehicle to be registered.

RESTRICTIONS AND REQUIREMENTS:

Current D.M.V. Registration, insurance, and driver's license as required by law.

- ♦ Well maintained show quality vehicles. Paint & chrome must be presentable and complete.
- ♦ Primered vehicles are acceptable, BUT must be all one color clean primer.
- ♦ Part-Primer, Part-Paint is NOT acceptable, nor are mismatched painted body parts.
- ♦ Body damage, visible rust, broken glass or torn upholstery is NOT acceptable.
- ♦ All street legal equipment (lights, etc.) is required on your vehicle.
- ♦ Exceptions for minor items may be made at the discretion of the organizers.
- ♦ Upon inspection of pre-registered vehicle, Organizers reserve the right to revoke Registration. If revoked, fee will be refunded within three weeks after event.
- ♦ Street legal vehicles only, unless waived by Organizers in writing.
- ♦ No unauthorized bicycles, skate boards, golf carts, and motorized carts allowed within event boundary.
- ♦ Vehicles activating hydraulics and/or air bags; flames from exhaust; obscene or offensive artwork, signs, stickers, etc. are prohibited.
- ♦ Open exhaust system rules are strictly enforced. Open Header Cruisin': 12noon to 6:00 p.m. Saturday Only.
- ♦ No "For Sale" signs are allowed. Discreet decal/paint is allowed.

REFUNDS:

- ♦ No Refunds.
- ♦ A \$25.00 charge will apply for all returned checks and may be subject to bank fees.
- ♦ All NSF and Stop Payment checks will automatically be sent to collections.

RESERVATION:

- ♦ Any participant attendee or his/her vehicle, by appearance or conduct, deemed objectionable by Organizer will be subject to removal from event boundary. All official event tags and entry fees paid will be forfeited.
- ♦ This includes persons, things, conduct, printed matter or any items not in keeping with the family nature of the event.

ADVERTISING & PUBLICITY RELEASES:

- ♦ By registering, car owners and/or guests agree to the usage of their names, pictures, and pictures of their vehicles for publicity, advertising, and commercial purposes (including but not limited to newspapers, magazines, radio, video and television, and internet) before, during and after the event and any activities connected with the event.
- ♦ All advertising and commercial rights are reserved by Organizers and the San Bernardino Convention & Visitors Bureau.

ALCOHOLIC BEVERAGES:

- ♦ Consumption of alcoholic beverages on public property, except when purchased and consumed in legally designated and posted vending areas, is illegal.
- ♦ All alcoholic beverage consumption laws will be strictly enforced.

ZERO TOLERANCE POLICY:

Our goal for the Rendezvous is to have a safe atmosphere for both the pedestrians and the cruisers:

- ♦ No Burnouts or Open Headers allowed (other than contest times or open header cruise time.)
- ♦ Participants will NOT be given a warning.
- ♦ Participant's vehicle will be removed from the event on first offense and registration number confiscated. No readmittance and no refund.
- ♦ Participants must abide by city parking and traffic laws prior to and after event times.
- ♦ Hanging over the side of vehicles and/or truck beds is unsafe and will not be permitted.
- ♦ No throwing of any items e.g. candy or promotional items from vehicles on the cruise route.

WAIVER OF LIABILITY:

By execution of this entry form, applicant hereby releases and discharges the event Organizers, their sponsor, the 2011 Route 66 Rendezvous Organizing Committee (Committee), the San Bernardino Convention & Visitors Bureau (SBCVB), the City and County of San Bernardino (City/County), the San Bernardino Economic Development Agency (EDA), and their directors, officers, employees, agents, representatives and servants, and anyone else connected with the management or conduct of this event from any and all known and unknown damages, injuries, losses, judgments and/or claims from any causes whatsoever that may be suffered by any member to his/her person or property; further, applicant expressly agrees to indemnify all the foregoing entities, firm, persons and bodies from any and all cooperating with the applicant and/or under the direction or control of the applicant.

Applicant agrees to obey all rules and regulations of event Organizers, the Committee, the SBCVB, the City/County, the EDA, and the State of California, which may be in effect at the time of the event. Applicant certifies the entered vehicle described on application has the proper automobile insurance, drivers license and D.M.V. Registration as required by law.
